TOURIST VISA

- * Passport valid at least six months (Attach all the old passports if applicable)
- * 1 Form (Electronically generated along with the bar code receipt, after feeding in all the details in website

<https://scedv.serpro.gov.br/frscedv/index.jsp> (visa form photo copy back to back filled by blue ink)

- * 2 photographs with white background 35 x 45 mm to be pasted on Electronic form,
- * Covering letter on Company Letterhead from the pax for stating purpose of visit
- * If employed-Letter from employer stating No Objection
- * Return confirm ticket
- * Hotel confirmation through fax directly from hotel in Brazil.
- * Original Bank Statement (personal for last 2 years)
- * Tax returns last three years
- * Foreign Exchange (min. US \$ 3000)
- * Educational qualification to be filled in the form (Compulsory)
- * Yellow Fever Certificate

Visiting Card of the applicant is MUST.

Maharashtra issued passport to be applied in mumbai only.

BUSINESS VISA

- * Passport valid at least six months (Attach all the old passports if applicable)
- * 1 Form (Electronically generated along with the bar code receipt, after feeding in all the details in website

- * 2 photographs with white background 35x45mm to be pasted on Electronic form
- * Covering letter in detail mentioning the day to day agenda and business activity in Brazil, must be signed by
the signing authority with name/designation/contact no. to be mentioned below signature.
- * Covering letter should also have the undertaking on passenger behalf taking full responsibilities for
passengers return to its native country before the visa expires.

- * Passenger visiting card
- * If employed-Letter from employer stating No Objection with above details
- * Return confirm ticket
- * Invitation letter from Brazil with full details of meeting purpose and duration etc, also mentioning address, tel no and e-mail address
- * Letter from Indian Chamber of commerce
- * Hotel confirmation through fax directly from hotel
- * Bank Statement (personal for last 3 months)
- * Educational qualification to be filled in the form (Compulsory).
- * Tax returns last three years
- * Foreign Exchange OR Credit Card Copy
- * Yellow Fever Certificate

Note: Yellow Fever certificate must while travelling
