Tourist Visa:

- Valid passport (+ old ppts) with atleast sixmonth validity from the date of travel
 - 1 Form with the mobile no of pax to be mentioned.
 - 2 Photos (The white background photo for each visa applicant submitted must measure 3.5 cms x 4.5 cms with the head centred in the frame. The head (measured from the top of the hair to the bottom of the chin) should measure about 3 cms)
 - Covering letter on Letterhead
 - Return Confirmed Ticket(showing departure after 5 days from the day the case is applied)
 - Exchange Or Credit Card Copy
 - Passengers contact details
 - Proof of Hotel confirmation from France (with address and contact details) if pax going to stay with any relative then relative should send original Attestation De Accueil from France
 - Original Insurance (only TATA, BAJAJ or ICICI, or any other insurance that has Repatriation Column duly filled and highlighted).
 - 3 months personal bank statement
 - 2 yrs personal IT papers
 - Occupational proof.
 - In case of child travelling, NOC from School OR College.

- NOTE : honeymoon couples can apply visa only after wedding with proof of wedding (spouse name endorsed on passport /marriage certificate)

Business Visa:

- Valid passport (+ old ppts) with atleast sixmonth validity from the date of travel
- 1 Form with the mobile no of pax to be mentioned
- 2 Photos (The white background photo for each visa applicant submitted must measure 3.5 cms x 4.5 cms with the head centred in the frame. The head (measured from the top of the hair to the bottom of the chin) should measure about 3 cms)
- Covering letter on Letterhead
- Return Confirmed Ticket (showing departure after 5 days from the day the case is applied)
- Hotel Confirmation
- Invitation
- Exchange Or Credit Card Copy

- Insurance (only TATA, BAJAJ or ICICI, or any other insurance that has Repatriation Column duly filled and highlighted).
- 3 months Personal as well as company bank statement
- three months salary certificate if employed
- 2 yrs personal IT papers
- Proof of occupation.
- Copy of Company Registration Certificate of Indian Company.
- For applicants going on training purposes, the invitee organisation has to get a clearance from the DDTEFP department of the French ministry in France and photocopy of the DDTEFP has to be attached with the covering letter from the invitee.

Photo Appearance: The photograph must be a full-face front view in which the visa applicant is facing the camera directly

The face should cover about 70-80 percent of the photo area

The photograph MUST be in color and have only a white or light background. Photos with dark busy or patterned backgrounds will not be accepted

In general the applicants head including both face and hair should be shown from the crown of the head to the tip of the chin on top and bottom and from hairline side-to-side. It is preferable that ears be exposed

Sunglasses or other wear which detracts from the face are not acceptable unless required for medical reasons an eye patch, for example.

A photograph depicting a person wearing a traditional facemask or veil that does not permit adequate identification is not acceptable
