Requirements For Tourist / Business Schengen Visa

Website For Norwegian Schengen Visa : www.norwayemb.org.in

Norway has joined the Schengen Convention to implement Schengen rules. The Norwegian Embassy, New Delhi started issuing visa exclusively from 25th March, 2001.

Visa application will be accepted from Mondays to Fridays between 10 am to 1 pm. (Excluding Saturday/Sunday/Public/Bank Holidays).

All documents must be submitted in duplicate and in the following order along with the originals for verification

- Valid passport with atleast sixmonth validity from the date of travel
- 1 Form
- 1 Photo (white or grey background, side poses not acceptable)
- Covering letter
- Checklist Form
- Return ticket showing departure minimum after 10 days
- Tour itinerary with Hotel voucher
- Medical Insurance (The date must get tally with ticket date)
- Insurance amount should be more than 30,000 Euro and should be valid after 15 days from the date of return
- Personal Bank Statement (last 6 months)
- Personal IT Return (last 3 years).
- If pax is under 18:
- if pax is travelling alone then original and a copy of consent signed by both parents and legalised
- if pax is travelling with only one of his/her parents the the consent letter in original and a copy from other parent required and legalized
- if the parent pax are travelling with has single custody then original and a copy of certificate of single custody required.
- Authority Letter (Format enclosed in Form Section).

FAMILY DETAILS MUST - MENTIONING NAME, RELATIONSHIP WITH PAX DATE OF BIRTH.

For Business visits:

- Invitation from the business partner in Norway must be submitted in duplicate.

- Recent correspondence between companies in India and Norway.

For Family visits:

- Official invitation / letter of guarantee on stipulated form, obtainable from the Department of Immigration in Norway.

For Tourist visits:

- Confirmed hotel booking and financial guarantee for the period of stay.
- Further documents may be required.
- Taking a tour then tour itinerary is required

For Seamen :

- Invitation from Norway.
- Copy of CDC.

If the seaman is going for briefing to Norway and then going to join the ship in another country other than Norway then a Medical Insurance is required.

For Cruise :

- Cruise itinerary
- Payment receipts made for the cruise

Processing Fees: to be submitted in Demand Draft in favour of The Royal Norwegian Consulate General, Mumbai_(Non refundable). Two copies of the D.D. to be submitted on an A4 size paper.

Courier Charges : Rs. 65/- (In cash)

Visa Fees less than 90 days : Rs. 4000/- (In Demand Draft)

Please Note:

No on the spot decisions will be taken. After receiving forms, the Embassy will take ten working days to process the application. If application is referred to Norway, a decision will take 2-4 months.

Submitting the requested documents does not automatically guarantee that the visa will be granted.

The possession of a visa does not guarantee entry into the Schengen states. In case the Schengen Immigration Officials refuse entry, the Embassy who has issued the visa cannot be held liable.
