**Tourist Visa:**

- \* Valid passport with atleast 6 months validity from the date of travel
- \* 2 forms
- \* 2 photos (with white background)
- \* Exchange (Minimum Euro 50 per day) Or Credit Card Copy with 3 months statement
- \* Covering Letter
- \* Return Confirmed ticket
- \* Day to day Tour Itinerary
- \* Hotel confirmation to be faxed directly from Croatia to the embassy and one copy with docs.
- \* Proof of Current Employment / business / School enrolment on official Letter head
- \* Personal Bank Statement (6 months)
- \* Personal IT Returns (last 3 years)
- \* Original Endorsement Receipt Of 1500 Euros Required

**AT THE TIME OF SUBMISSION RECIEPT OF THE FEES AMOUNT DEPOSITED IN BANK IS REQUIRED**

Visa Fees: Rs. 2210/-

Note: Time Taken: Next day after the approval is received

VISA SECTION WORKING DAYS: Monday to Thursday

If Schengen visa is valid between the travels to Croatia then visa can be obtained in 4-7 working days OR ELSE Visa can take 12/16 working days.

**Business Visa:**

- \* Valid passport with atleast 6 months validity from the date of travel
- \* 3 Forms
- \* 3 Photos (with white background)
- \* Covering letter
- \* Return Ticket
- \* Exchange (Minimum Euro 50 per day) Or Credit Card Copy with 3 months statement
- \* Original Invitation in Proper format including signature and the company seal. The

format is given in the visa form section of our website.

- \* Original Letter of Guarantee filled by guarantor - legal person from Croatia (format enclosed with form, Jamstveno pismo pravne osobe)
- \* Guarantor - legal person shall enclose to the letter of guarantee a document proving its liquidity (Bon 1, Bon 2, certificate of the commercial court that no liquidation proceedings have been initiated, etc.)
- \* The letter of guarantee shall be signed by the person authorized to represent the guarantor and certified by official stamp.
- \* Proof of Current Employment / business / School enrolment on official Letter head.
- \* Personal Bank Statement (6 months)
- \* Personal IT Returns (last 3 years).
- \* Insurance.
- \* Credit card copy
- \* Ticket along with purchase bill of tkt
- \* Original Endorsement Receipt of 1500 euro required

AT THE TIME OF SUBMISSION RECIEPT OF THE FEES AMOUNT DEPOSITED IN BANK IS REQUIRED

Visa Fees: Rs.2450/-

Note: Time Taken: Next day after the approval is received

VISA SECTION WORKING DAYS: Monday to Thursday

If Schengen visa is valid between the travels to Croatia then visa can be obtained in 3-5 working days OR ELSE Visa can take 10/15 working days
