Tourist:

- Valid Passport with atleast 6 months validity from the date of Travel.
- 1 Form
- 2 Photos (with white background)
- Covering letter explaining the reason of trip to Cyprus
- Return Ticket Showing Departure Minimum After 4 Days
- Exchange minimum EURO 1500 endorsed in the passport
- Hotel Confirmation from hotel in Cyprus as per ticket dates to be faxed to Embassy in Delhi and 1 copy to us.
- Bank guarantee letter from bank in cyprus attested from immigration dept in cyprus to us and emb (For Sponsorship Cases)
- Original Bank Statement last three months
- Copy Of IT Papers for last 2 years.
- Assumption of Responsibility Form Filled By Sponsor To Be Faxed In Embassy Must (For Sponsorship Cases)

Business Visa:

- Valid Passport with atleast 6 months validity from the date of Travel.
- 1 Form must be duly completed and signed by the applicant
- 2 Photos (with white background)
- Covering letter explaining the reason of trip to Cyprus (i.e. the subject that will be discussed, duration of the trip, sponsorship of air ticket, travel expenses)
- Return Ticket Showing Departure Minimum After 4 Days
- Invitation should be faxed directly from Cyprus Party to Embassy and 1 copy to us.
- Exchange minimum USD 1500 endorsed in the passport
- ORIGINAL RECEIPT OF FOREIGN EXCHANGE.
- Hotel Confirmation from hotel in Cyprus as per ticket dates to be faxed to Embassy and 1 copy to us.
- Bank guarantee letter from bank in cyprus attested from immigration dept in cyprus to us and emb must

- Sufficient funds (with receipt in original & photocopy) must be endorsed on the passport for at least \$ 2000 for a fifteen days stay in Cyprus. The endorsement should make a reference to Cyprus as the country of destination. OR Copy of the international credit card with credit card statements for three months in original & photocopy.
- Letter from the employer
- Companies registration certificate
- Certification from the Chambers of Commerce
- Industry
- IT Papers for last 2 years.
- Copy of memorandum of articles (complete set)
- Assumption of Responsibility Form Filled By Sponsor To Be Faxed In Embassy Must

The timings for filing of visa documents are from 10 a.m. to 1 p.m. Three working days are required for processing of visa. Securing a tourist visa from the High Commission does not guarantee an automatic entry into Cyprus. The Migration Authorities at the airport can always deny entry to any foreigner, even if the latter has been issued with a tourist visa.

Additional documents may be required in certain cases.

Note: All faxes should be sent to the CYPRUS HIGH COMMISSION, Delhi

Please note that all visa applications have to be made in Delhi ONLY.

Processing fees Rs. 700/- (single entry)

Rs 2034/- (Multiple entry)

Per VISA which is non refundable.

Note: 1. For multiple entry Visa original Police Clearance Certificate from passport office attested from Ministry of External Affairs New Delhi, is must
